1. Material of construction	<b>100 % virgin High Density Polyethylene (HDPE) that is odourless and transparent.</b>
2. Brimful capacity	60 mℓ
<b>3. Dimensions:</b>	<b>Please refer to drawing as per Appendix 1</b>
3a: Total Height of the bottle	70.0mm ± 0.50mm (69.50 – 70.50 mm)
3b: Bottom Width of the bottle	41mm ± 0.50mm (40.50 - 41.50mm)
3c: Internal diameter of the bottle neck-rim	<b>13.0mm ± 0.20mm (12.80 - 13.20 mm)</b>
3d: Outside diameter of the bottle neck rim	<b>20.0mm ± 0.20mm (19.80 – 20.20mm)</b>
3e: Thickness of the bottle brim	<b>3.70mm ± 0.20mm (3.50 – 3.90 mm)</b>
3f: Outer diameter of the neck of the Bottle	15.8mm ± 0.25mm (15.55 – 16.05mm)
3g: Shape of the bottle	As per attached diagram with the bottom of the bottle being concave(“B”) and the surface smooth. The rim circumference must be <b>Flat</b> and not round and free from inwards or outwards <b>projections. (Refer to appendix 1 for Brim angle, bottom curve and R degrees)</b>

<b>5. Quality Control samples for testing purposes at OBP</b>	<b>Samples to be drawn from the beginning, middle and end of the production line over a 12 hour period. The samples must be labelled with the product name, Date ,Time ,batch number and signature of operator.</b>
6. Gamma Irradiation requirements	Minimum dose NLT 8 kGy Certificate must be attached.
7. Stores acceptance criteria	<b>847 bottles must be packed onto a cardboard tray (460mm x 460mm x 50mm). 12 trays must be sealed against dust penetration in 2 plastic bags of at least 35g. The 12 trays sealed in the plastic bags must then be packed in a firm cardboard box (470x470x546)that is strong enough to stack 4 boxes on top of each other.The Individual boxes must be sealed in a plastic shroud to prevent entry of dust.</b>
8. Certificate of conformance /analysis	Each consignment of bottles must have a certificate of conformance/analysis attached when it arrives at stores. The certificate must be signed by <b>the supplier</b> on a <b>company's</b> letterhead.
