Background

Onderstepoort Biological Products SOC Ltd is a State-owned company which reports to the Minister of Agriculture. OBP falls under schedule 3B of the Public Finance Management Act. OBP manufactures vaccines that are distributed within and outside the borders of the Republic of South Africa.

OBP operates under the national Key Point Act 102 of 1980 as reaffirmed in 2003.

The specification requires that one service provider must be able to provide a complete solution of rendering security guarding services (Physical Security) to OBP.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices, or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
