## TERMS OF REFERENCE

**Request for Information regarding the Optimal Land-Use, Development Options, and Feasibility for House Numbers 16,17,25,27,28,30,31,32 and 33 Flip Fourie Street, Old Soutpan Road, Onderstepoort, Pretoria North.**

### **1. BUSINESS INTRODUCTION**

OBP is a manufacturer of animal vaccines. These products are sold within domestic market mainly to coops, feedlots, wholesalers, veterinarians, and pharmacies. The company has further segmented its market according to provinces, with each province having various distribution points. Most of these distribution points are mainly in rural areas dominated by cattle, sheep, and goat farmers.

### **2. BACKGROUND AND SITE DESCRIPTION**

The Entity owns a property located at Flip Fourie Street, Old Soutpan Road, Onderstepoort, Pretoria North, approximately 600m from its Onderstepoort administrative campus.

- Current State: The property includes existing residential structures in various states of disrepair.
- Strategic Context: Given its proximity to the campus, the Entity wishes to explore uses that align with its mandate, employee needs, or commercial optimization.

### **3. REQUESTED INFORMATION**

Respondents are requested to provide a high-level "Concept and Options" paper covering:

#### **3.1. Development Options**

Present at least two (2) viable use-cases for the property (e.g., staff accommodation, mixed-use commercial, or total redevelopment).

- Legal Permissibility: Identify potential rezoning requirements under the City of Tshwane's current land-use management system.
- Physical Feasibility: Comment on whether existing structures should be renovated or demolished.

#### **3.2. Financial and Economic Indicators**

- Indicative Costs: High-level estimates for demolition, construction, or refurbishment.
- Revenue Models: Potential rental yields or long-term lease values.
- Economic Impact: Potential for B-BBEE participation and local job creation in the Pretoria-North area.

#### **3.3. Implementation and Risk**

- Timelines: Anticipated duration for rezoning, construction, and commissioning.

- Risk Matrix: Identify key risks (e.g., heritage restrictions, environmental, or security) and suggested mitigations.
