1.	Material of construction	Tubular colourless Type I glass
2.	Brimful capacity	10.0 mL
3.	Dimensions:	Please refer to drawing as per Appendix 1
3a:	Total Height of the bottle	40.0mm $\pm$ 0.50mm (39.50 – 40.50 mm)
3b:	Bottom Width of the bottle	22.0mm $\pm$ 0.20mm (21.80 - 22.80 mm)
3c:	Internal diameter of the bottle neck rim	12.6 mm $\pm$ 0.20 mm (12.40 - 12.80 mm)
3d:	Outside diameter of the bottle neck rim	20.0 mm $\pm$ 0.20 mm (19.80 – 20.20 mm)
3e:	Thickness of the bottle brim	3.60 mm $\pm$ 0.20 mm (3.40 – 3.80 mm)
3f:	Outer diameter of the neck of the Bottle	16.50 max
3g:	Shape of the bottle	As per attached diagram with the bottom of the bottle being concave (“B”) and the surface smooth. The rim circumference must be flat and not round and free from inwards or outwards projections. (Refer to appendix 1 for Brim angle, bottom curve and R degrees).
4.	Mass one bottle	8.30g
5.	Quality Control samples for testing purposes at OBP	Samples to be drawn from the beginning, middle and end of the production line over a 12 hour period. The samples must be labelled with the product name, Date, Time, batch number and signature of operator.
6.	Stores acceptance criteria	To be packed upright in plastic corrugated trays with the follow dimensions in mm - 240 wide x 590 long x 35 high. The tray to have a self-opening end on the 240 mm side. 310 Bottles to be packed upright in 31 staggered rows, 10 bottles to a row. The whole tray with bottles to be shrink-wrapped. 160 of this trays to be packed in 8 rows of 20 high into a sturdy carton container with a lid. This carton container to be fixed onto a wooden pallet. The pallet and the box to be shrink-wrapped with heavy duty plastic to render and keep it dust- and waterproof.
7.	Certificate of conformance / analysis	Each consignment of bottles must have a certificate of conformance / analysis attached when it arrives at stores. The certificate must be signed by the supplier on a company’s letterhead.
